

# Health Coverage for All Children: California

#### All Children Need Health Coverage that is Affordable, Comprehensive, and Simple.

### Health Coverage for California's Children:

- 1,119,000 uninsured (11.2% of all children).
- 4,361,486 children are enrolled in Medicaid.
- 1,731,605 children are enrolled in the Children's Health Insurance Program (CHIP).

#### How affordable is health coverage for California's children?

- CHIP eligibility is up to 250 percent of poverty (\$55,875 for a family of four), plus income deductions.
- Medicaid eligibility is 200 percent of poverty (\$44,700) for children 0-1, 133 percent of poverty (\$29,726) for children 1-5, and 100 percent of poverty (\$22,350) for children 6-19.

## How simple are enrollment procedures in CHIP and Medicaid for California's children? T

- Simplification procedures:
  - 12-month continuous eligibility
  - Presumptive eligibility for children in families up to 200 percent of poverty.
  - No asset test
  - No face-to-face interview for children
  - Joint application
- Barriers that remain:
  - 3 month waiting period for CHIP
  - No administrative verification of income—the state requires parents to provide proof of income before a child can get health coverage.
