## Children's Defense Fund Health Coverage for All Children: Kansas

### All Children Need Health Coverage that is Affordable, Comprehensive, and Simple.

#### Health Coverage for Kansas' Children:

- 68,000 children are uninsured (9.2% of all children).<sup>\*</sup>
- 208,695 children are enrolled in Medicaid.
- 56,384 children are enrolled in the Children's Health Insurance Program (CHIP).

#### How affordable is health coverage for Kansas' children?<sup>†</sup>

- CHIP eligibility is up to 241 percent of poverty (\$44,700 for a family of four).
- Medicaid eligibility is 150 percent of poverty (\$33,525) for children 0-1, 133 percent of poverty (\$29,726) for children 1-5, and 100 percent of poverty (\$22,350) for children 6-19.

#### How simple are enrollment procedures in CHIP and Medicaid for Kansas' children?

- Simplification procedures:
  - 12-month continuous eligibility
  - Presumptive eligibility—which allows children to see a doctor while their application is still being processed
  - No waiting period
  - No face-to-face interview
  - No asset test
  - Joint application
- Barriers that remain:
  - No administrative verification of income—the state requires parents to provide proof of income before a child can get health coverage
  - 8 month waiting period

# Do children in Kansas' CHIP program receive the same comprehensive benefits as children in Medicaid?

 Yes.
