

# Health Coverage for All Children: Montana

#### All Children Need Health Coverage that is Affordable, Comprehensive, and Simple.

#### **Health Coverage for Montana's Children:**

- 28,000 children are uninsured (11.8% of all children).
- 60,891 children are enrolled in Medicaid.
- 25,231 children are enrolled in the Children's Health Insurance Program (CHIP).

## How affordable is health coverage for Montana's children?<sup>†</sup>

- Healthy Montana Kids (HMK), formerly known as CHIP, extends eligibility up to 250 percent of poverty (\$55,875 for a family of four).
- HMK Plus (formerly children's Medicaid) eligibility is up to 133 percent of poverty (\$29,726) for children 0-5 and 100 percent of poverty (\$22,350) for children 6-19.

### How simple are enrollment procedures in CHIP and Medicaid for Montana's children?

- Simplification procedures:
  - 12-month continuous eligibility for children in HMK and HMK Plus
  - No Asset Test
  - No face-to-face interview
  - Joint application
  - Presumptive eligibility—which allows children to see a doctor while their application is still being processed.
- Barriers that remain:
  - Applicants must provide proof of citizenship for children not born in Montana.
  - Children must be uninsured for three months prior to being enrolled in HMK (No uninsured period for children enrolled in HMK *Plus*).
  - No administrative verification of income—the state requires parents to provide proof of income before a child can get health coverage.
