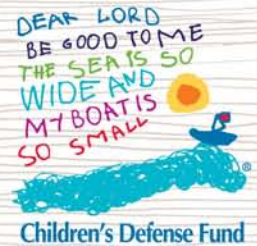

Health Coverage for All Children: Oklahoma

All Children Need Health Coverage that is Affordable, Comprehensive, and Simple.

Health Coverage for Oklahoma's Children:

- 111,000 children are uninsured (11.4% of all children). *
- 493,682 children are enrolled in Medicaid. **
- 122,874 children are enrolled in the Children's Health Insurance Program (CHIP). ***

How affordable is health coverage for Oklahoma's children? †

- Children's eligibility is up to 185 percent of poverty (\$41,348 for a family of four) through Oklahoma's Medicaid expansion program (includes CHIP).

How simple are enrollment procedures in CHIP and Medicaid for Oklahoma's children?

- Simplification procedures:
 - No face-to-face interview
 - No asset test
 - No waiting period
 - Administrative verification of income
- Barriers that remain:
 - No 12-month continuous eligibility
 - No presumptive eligibility—which forces children to wait until their application is processed before they can see a doctor.

Do children in Oklahoma's CHIP program receive the same comprehensive benefits as children in Medicaid?

- Yes. Oklahoma is one of 13 states (plus the District of Columbia) that has used CHIP funding to cover all children eligible for CHIP and Medicaid under one program. As a result, children in CHIP in these states receive the same comprehensive health and mental health coverage (through the Early and Periodic Screening Diagnostic and Treatment (EPSDT) benefit) that all children in Medicaid receive.
