

Health Coverage for All Children: Oregon

All Children Need Health Coverage that is Affordable, Comprehensive, and Simple.

Health Coverage for Oregon's Children:

- 107,000 children are uninsured (11.6% of all children).
- 267,878 children are enrolled in Medicaid.
- 64,727 children are enrolled in the Children's Health Insurance Program (CHIP). ***

How affordable is health coverage for Oregon's children? †

- CHIP eligibility is up to 300 percent of poverty (\$67,050 for a family of four).
- Medicaid eligibility is 133 percent of poverty (\$29,726) for children 0-5 and 100 percent of poverty (\$22,350) for children 6-19.

How simple are enrollment procedures in CHIP and Medicaid for Oregon's children?

- Simplification procedures:
 - 12-month continuous eligibility
 - No face-to-face interview
 - Joint application
 - No asset test
- Barriers that remain:
 - 2 month waiting period
 - No presumptive eligibility—which forces children to wait until their application is processed before they can see a doctor
 - No administrative verification of income—the state requires parents to provide proof of income before a child can get health coverage

Do children in Oregon's CHIP program receive the same comprehensive benefits as children in Medicaid?

Yes. Oregon provides children in its CHIP program the same comprehensive health and mental health coverage (through the Early and Periodic Screening Diagnostic and Treatment (EPSDT) benefit) that all children in Medicaid receive.
