## Illinois

#### The Children

- 318,042 children under age 18 live in homes where the householders are grandparents or other relatives (10.2% of the children in the state.) (U.S. 2010 Census)
  - Of these, 236,424 live with grandparents who are the householders (7.6% of the children in the state) and 81,618 live with other relatives who are the householders (2.6% of the children in the state). (U.S. 2010 Census)
- 109,939 children live in homes with grandparent householders where grandparents are responsible for them.\*
  - Of these children, 35,583 have no parents present in the home.\*

#### The Grandparents\*

- 99,783 grandparents are the householders and are responsible for their grandchildren living with them. Of these:
  - 44% of the grandparents are White and not Hispanic, 35% are Black/African American, 2% are Asian, and 17% are Hispanic/Latino, and may be of any race.
  - o 31% have no parents of the children present in the home.
  - o 68% are under age 60.
  - 20% live in poverty.\*\*
- 31,686 grandparents in Chicago city and 1,290 in Rockford city are the householders and are responsible for their grandchildren living with them.

## **Children in Foster Care**

- Sometimes state child welfare agencies place children in foster care with grandparents or other relatives. This is often called "kinship care."
- Federal law requires states to notify all known relatives within 30 days of children's removal from their parents.

#### In 2010 in Illinois:

- 15,540 children in substitute care under supervision of Illinois Department of Children and Family Services (DCFS).
- Of these children, 6,371 were in kinship foster care.

#### **Placement Policies**

- Placements should be consistent with the best interest, safety and special needs of a child.
   This may include placement with relatives.
- There is no separate licensing program for kinship foster parents. Relatives must meet the same licensing standards and receive the same foster care payment rate as non-kin foster parents. A relative can be a non-licensed foster parent if certain safety standards are met and can receive 100% of the "standard of need" payment. The "standard of need" payment is more than a TANF child-only grant, but is lower than a foster care board payment.

Extended Family Support Program (EFSP) provides services to kinship care families
through collaboration with the probate court, the Department of Public Aid, the State Central
Register and the public schools. The focus of the program is short-term, home stabilization
to help relatives provide quality care. The program provides a small cash allowance and
assists families in obtaining guardianship, getting public aid and enrolling in school.

#### **Subsidized Guardianship**

- Illinois is implementing the Federal Guardianship Assistance Program (GAP). GAP provides guardianship subsidies for eligible children who have been living with relatives in foster care and cannot return to their parents, and for whom adoption has been ruled out. Children receiving guardianship subsidies are in permanent placement with relatives and are no longer in foster care.
- In Illinois, the guardianship subsidy rate is the same as the state's foster care and adoption subsidy rates.
- Additional eligibility requirements include children who are living with licensed kin for at least 6 months and the home has been licensed for at least the same 6 months. Other criteria may limit eligibility so it is important that this option be discussed with the child's caseworker.
- Post-guardianship program is also available to provide resources and referrals as needed.

## **Public Benefits**

Federal and state public benefits programs can help with income, food, healthcare, home energy, telephone and other needs for those who are eligible. Eligibility requirements vary with each public benefit and sometimes are different from state to state. Some benefits are for the family and others are for children or older adults individually. Children are often eligible for public benefits even if their caregivers do not have legal guardianship or custody. Grandparents may become eligible for benefits programs when their household size increases.

#### Income

#### **Social Security**

A multigenerational program, Social Security provides income benefits to adults, older adults and children. In addition to Retirement and Disability benefits, Survivor's Benefits are based on a child's parent's earnings and may help if a child's parents die. The Supplemental Security Income (SSI) program pays benefits to disabled adults and children who have limited income and resources. SSI benefits are also payable to people 65 and older without disabilities who meet the financial limits.

#### **Nutrition**

Relative caregivers and their families may be eligible for assistance with groceries, meals, infant formula and nutrition education. These are some of the key nutrition benefits programs and resources.

#### **Supplemental Nutrition Assistance Program (SNAP)**

SNAP is the new name for the federal Food Stamp Program. It helps low-income individuals and families buy the food they need for good health. Although SNAP is the national name, your state may use a different name.

Child Nutrition Program - The schools, early childhood education programs, child care
centers, afterschool programs or other programs that children attend may offer free or
reduced meals through the federal Child Nutrition Program, which provides breakfast, lunch,
snacks, summer meals and milk. Contact the school or program to ask if they participate in
any of the child nutrition programs and ask how to apply. Relative caregivers should inform
the program that they are raising the child and whether or not they are doing so through a
court order.

#### **Educational Enrollment**

Relative caregivers can contact their local school district's administrative office or their local school to find out how to register the child and what paperwork is needed. Caregivers may need birth records, health records or previous school records. Some states have laws that allow relative caregivers to enroll children they are raising in school. These laws are often called "education consent" laws, but may be called something else in your state.

## Early Intervention, Special Education and Related Services

#### What you need to know:

- The Federal Individuals with Disabilities Act (IDEA) From birth to age 21, children who
  have learning disabilities, physical disabilities or other special needs may be able to get
  special early intervention, preschool and special education services in school through the
  federal IDEA. Services may include speech, physical, and occupational therapies.
- Child Find A part of the IDEA that requires states to identify, locate and evaluate children
  in the areas of cognitive and physical functioning, hearing and vision, speech and language
  and social and emotional development as early as possible. Once the Child Find evaluation
  team, which includes a child's caregivers, has decided if a child is eligible for early
  intervention or preschool special education services, an Individual Family Service Plan
  (IFSP; birth to three years of age) or an Individual Education Plan (IEP; three to five years of
  age) is developed and services begin shortly at no cost.
