

# Children in the States 2019

## ALABAMA



### Child Population

- **1,095,473** children lived in Alabama in 2017.
- **42 percent** were children of color: 29 percent were Black; 8 percent were Hispanic; 2 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

### Child Poverty

- **25 percent** of Alabama's children were poor in 2017—a total of **265,078** children—and children of color were disproportionately poor.
- **41 percent** of Black, **40 percent** of Hispanic and **14 percent** of White children were poor.
- **11 percent** of children were extremely poor (their family had income below half the poverty level).
- **28 percent** of children under 6 were poor.

### Income and Wealth Inequality

- **\$74,800** was the median income for White families with children compared with **\$30,600** for Black and **\$32,300** for Hispanic families in 2017.

### Housing and Homelessness

- **15,931** homeless children were enrolled in public schools during 2016-2017.
- **2 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

### Child Hunger and Nutrition

- **23 percent** of children lived in food-insecure households in 2016.
- **33 percent** of children ages 10-17 were overweight or obese in 2017.
- **20 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **90 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

### Child Health

- **36,049** children ages 0-18 (**3 percent**) were uninsured in 2017.
- **820,611** children ages 0-18 were enrolled in Medicaid and All Kids (Children's Health Insurance Program) in FY2017.

### Early Childhood

- **\$5,858** was the average annual cost for an infant in center-based child care in 2017.
- **28 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

### Education

- **82 percent** of Black, **85 percent** of Hispanic and **58 percent** of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- **88 percent** of Black, **86 percent** of Hispanic and **62 percent** of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- **85 percent** of Black, **87 percent** of Hispanic and **89 percent** of White students graduated high school on time during 2015-2016.
- **15 percent** of Black, **3 percent** of Hispanic and **4 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

### Child Welfare

- **10,847** children were abused or neglected in 2017.
- **5,631** children were in foster care on the last day of FY2017.

### Juvenile Justice

- **849** children were in residential placement in 2015. **60 percent** were Black; **3 percent** were Hispanic; and **35 percent** were White.
- **27** children were in adult jails or prisons in 2016.

### Gun Violence

- **84** children and teens were killed with guns in 2017.
