# Children in the States 2019 **ALASKA**



## **Child Population**

- 184,928 children lived in Alaska in 2017.
- 51 percent were children of color: 3 percent were Black; 10 percent were Hispanic; 7 percent were Asian/Native Hawaiian/Other Pacific Islander; and 18 percent were American Indian/Alaska Native.

## **Child Poverty**

- 15 percent of Alaska's children were poor in 2017–a total of 26,865 children–and children of color were disproportionately poor.
- 14 percent of Black, 11 percent of Hispanic and
  9 percent of White children were poor.
- **7 percent** of children were extremely poor (their family had income below half the poverty level).
- 15 percent of children under 6 were poor.

# **Income and Wealth Inequality**

 \$93,200 was the median income for White families with children compared with \$70,300 for Hispanic families in 2017.

## **Housing and Homelessness**

- 4,041 homeless children were enrolled in public schools during 2016-2017.
- 2.5 full-time jobs at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

## **Child Hunger and Nutrition**

- 19 percent of children lived in food-insecure households in 2016.
- 24 percent of children ages 10-17 were overweight or obese in 2017.
- 24 percent of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- 90 percent of children receiving free or reducedprice lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

#### Child Health

- 18,722 children ages 0-18 (10 percent) were uninsured in 2017.
- 117,542 children ages 0-18 were enrolled in Denali KidCare (combined Medicaid and Children's Health Insurance Program) in FY2017.

# **Early Childhood**

- \$11,832 was the average annual cost for an infant in center-based child care in 2017.
- 3 percent of 4-year-olds were enrolled in statefunded preschool during 2017-2018.

## **Education**

- 73 percent of Black, 74 percent of Hispanic and
  61 percent of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- 86 percent of Black, 73 percent of Hispanic and 63 percent of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- 74 percent of Black, 76 percent of Hispanic and 81 percent of White students graduated high school on time during 2015-2016.
- 9 percent of Black, 5 percent of Hispanic and 3 percent of White public secondary students had at least one out-of-school suspension in 2013-2014.

## **Child Welfare**

- 2,783 children were abused or neglected in 2017.
- 2,766 children were in foster care on the last day of FY2017.

## **Juvenile Justice**

- 207 children were in residential placement in 2015. 14 percent were Black; 1 percent were Hispanic; and 38 percent were White.
- 4 children were in adult jails or prisons in 2016.

## **Gun Violence**

**25** children and teens were killed with guns in 2017.
