

Children in the States 2019

COLORADO



Child Population

- **1,261,833** children lived in Colorado in 2017.
- **44 percent** were children of color: 4 percent were Black; 31 percent were Hispanic; 3 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **12 percent** of Colorado's children were poor in 2017—a total of **149,043** children—and children of color were disproportionately poor.
- **17 percent** of Black, **20 percent** of Hispanic and **7 percent** of White children were poor.
- **5 percent** of children were extremely poor (their family had income below half the poverty level).
- **13 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$100,900** was the median income for White families with children compared with **\$55,200** for Black and **\$50,800** for Hispanic families in 2017.

Housing and Homelessness

- **21,062** homeless children were enrolled in public schools during 2016-2017.
- **2.3 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

Child Hunger and Nutrition

- **15 percent** of children lived in food-insecure households in 2016.
- **28 percent** of children ages 10-17 were overweight or obese in 2017.
- **18 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **91 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

Child Health

- **57,483** children ages 0-18 (**4 percent**) were uninsured in 2017.
- **683,948** children ages 0-18 were enrolled in Health First Colorado (Medicaid) and Child Health Plan Plus (Children's Health Insurance Program) in FY2017.

Early Childhood

- **\$14,960** was the average annual cost for an infant in center-based child care in 2017.
- **23 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- **79 percent** of Black, **77 percent** of Hispanic and **49 percent** of White 4th grade public school students could not read at grade level in 2017.
- **79 percent** of Black, **75 percent** of Hispanic and **50 percent** of White 8th grade public school students could not read at grade level in 2017.
- **72 percent** of Black, **70 percent** of Hispanic and **84 percent** of White students graduated high school on time during 2015-2016.
- **11 percent** of Black, **6 percent** of Hispanic and **3 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- **11,578** children were abused or neglected in 2017.
- **5,704** children were in foster care on the last day of FY2017.

Juvenile Justice

- **999** children were in residential placement in 2015. **21 percent** were Black; **39 percent** were Hispanic; and **36 percent** were White.
- **4** children were in adult jails or prisons in 2016.

Gun Violence

- **59** children and teens were killed with guns in 2017.
