# Children in the States 2019 FLORIDA



## **Child Population**

- 4,201,983 children lived in Florida in 2017.
- 58 percent were children of color: 20 percent were Black; 31 percent were Hispanic; 3 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.</li>

## **Child Poverty**

- 20 percent of Florida's children were poor in 2017–a total of 840,179 children–and children of color were disproportionately poor.
- 32 percent of Black, 25 percent of Hispanic and
   12 percent of White children were poor.
- **9 percent** of children were extremely poor (their family had income below half the poverty level).
- 22 percent of children under 6 were poor.

## **Income and Wealth Inequality**

\$78,300 was the median income for White families with children compared with \$40,500 for Black and \$46,100 for Hispanic families in 2017.

## **Housing and Homelessness**

- 75,106 homeless children were enrolled in public schools during 2016-2017.
- 2.6 full-time jobs at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

# **Child Hunger and Nutrition**

- 21 percent of children lived in food-insecure households in 2016.
- 36 percent of children ages 10-17 were overweight or obese in 2017.
- 29 percent of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- 84 percent of children receiving free or reducedprice lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

#### Child Health

- 324,860 children ages 0-18 (7 percent) were uninsured in 2017.
- 2,835,486 children ages 0-18 were enrolled in Medicaid and Kid Care (Children's Health Insurance Program) in FY2017.

# **Early Childhood**

- \$9,018 was the average annual cost for an infant in center-based child care in 2017.
- **77 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

#### **Education**

- 77 percent of Black, 64 percent of Hispanic and 47 percent of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- 80 percent of Black, 69 percent of Hispanic and 56 percent of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- 72 percent of Black, 80 percent of Hispanic and 85 percent of White students graduated high school on time during 2015-2016.
- 10 percent of Black, 4 percent of Hispanic and 4 percent of White public secondary students had at least one out-of-school suspension in 2013-2014.

### **Child Welfare**

- 40,103 children were abused or neglected in 2017.
- 24,641 children were in foster care on the last day of FY2017.

#### **Juvenile Justice**

- 2,853 children were in residential placement in 2015. 62 percent were Black; 9 percent were Hispanic; and 29 percent were White.
- **143** children were in adult jails or prisons in 2016.

#### **Gun Violence**

204 children and teens were killed with guns in 2017.
