

# Children in the States 2019

## IOWA



### Child Population

- **731,947** children lived in Iowa in 2017.
- **22 percent** were children of color: 5 percent were Black; 10 percent were Hispanic; 3 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

### Child Poverty

- **12 percent** of Iowa's children were poor in 2017—a total of **88,070** children—and children of color were disproportionately poor.
- **44 percent** of Black, **22 percent** of Hispanic and **9 percent** of White children were poor.
- **5 percent** of children were extremely poor (their family had income below half the poverty level).
- **15 percent** of children under 6 were poor.

### Income and Wealth Inequality

- **\$80,500** was the median income for White families with children compared with **\$26,300** for Black and **\$45,300** for Hispanic families in 2017.

### Housing and Homelessness

- **6,789** homeless children were enrolled in public schools during 2016-2017.
- **2.1 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

### Child Hunger and Nutrition

- **16 percent** of children lived in food-insecure households in 2016.
- **33 percent** of children ages 10-17 were overweight or obese in 2017.
- **15 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **89 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

### Child Health

- **24,044** children ages 0-18 (**3 percent**) were uninsured in 2017.
- **433,933** children ages 0-18 were enrolled in Iowa Medicaid Enterprise (Medicaid) and Hawk-I (Children's Health Insurance Program) in FY2017.

### Early Childhood

- **\$10,131** was the average annual cost for an infant in center-based child care in 2017.
- **65 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

### Education

- **92 percent** of Black, **79 percent** of Hispanic and **59 percent** of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- **85 percent** of Black, **73 percent** of Hispanic and **61 percent** of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- **80 percent** of Black, **85 percent** of Hispanic and **93 percent** of White students graduated high school on time during 2015-2016.
- **11 percent** of Black, **3 percent** of Hispanic and **2 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

### Child Welfare

- **10,643** children were abused or neglected in 2017.
- **5,952** children were in foster care on the last day of FY2017.

### Juvenile Justice

- **675** children were in residential placement in 2015. **29 percent** were Black; **9 percent** were Hispanic; and **56 percent** were White.
- **7** children were in adult jails or prisons in 2016.

### Gun Violence

- **28** children and teens were killed with guns in 2017.
