# Children in the States 2019 **KENTUCKY**



# **Child Population**

- 1,010,539 children lived in Kentucky in 2017.
- 21 percent were children of color: 9 percent were Black; 6 percent were Hispanic; 2 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.</li>

# **Child Poverty**

- 22 percent of Kentucky's children were poor in 2017–a total of 222,906 children–and children of color were disproportionately poor.
- 35 percent of Black, 33 percent of Hispanic and
  20 percent of White children were poor.
- **11 percent** of children were extremely poor (their family had income below half the poverty level).
- 25 percent of children under 6 were poor.

# **Income and Wealth Inequality**

• \$67,300 was the median income for White families with children compared with \$32,400 for Black and \$38,700 for Hispanic families in 2017.

# **Housing and Homelessness**

- 26,826 homeless children were enrolled in public schools during 2016-2017.
- **2 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

# **Child Hunger and Nutrition**

- 19 percent of children lived in food-insecure households in 2016.
- **40 percent** of children ages 10-17 were overweight or obese in 2017.
- 38 percent of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- 92 percent of children receiving free or reducedprice lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

#### Child Health

- 40,906 children ages 0-18 (4 percent) were uninsured in 2017.
- 642,364 children ages 0-18 were enrolled in Kentucky Medicaid and KCHIP (Children's Health Insurance Program) in FY2017.

# **Early Childhood**

- \$6,258 was the average annual cost for an infant in center-based child care in 2017.
- **29 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

## **Education**

- 84 percent of Black, 73 percent of Hispanic and
  59 percent of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- 84 percent of Black, 72 percent of Hispanic and
  63 percent of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- 81 percent of Black, 82 percent of Hispanic and 90 percent of White students graduated high school on time during 2015-2016.
- 12 percent of Black, 3 percent of Hispanic and 4 percent of White public secondary students had at least one out-of-school suspension in 2013-2014.

# **Child Welfare**

- 22,410 children were abused or neglected in 2017.
- 8,089 children were in foster care on the last day of FY2017.

## **Juvenile Justice**

- 510 children were in residential placement in 2015. 34 percent were Black; 2 percent were Hispanic; and 56 percent were White.
- **0** children were in adult jails or prisons in 2016.

#### **Gun Violence**

72 children and teens were killed with guns in 2017
