# Children in the States 2019 MICHIGAN



# **Child Population**

- **2,176,649** children lived in Michigan in 2017.
- 33 percent were children of color: 16 percent were Black; 8 percent were Hispanic; 3 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.</li>

## **Child Poverty**

- 20 percent of Michigan's children were poor in 2017—a total of 419,449 children—and children of color were disproportionately poor.
- 41 percent of Black, 27 percent of Hispanic and
   13 percent of White children were poor.
- **9 percent** of children were extremely poor (their family had income below half the poverty level).
- 23 percent of children under 6 were poor.

# **Income and Wealth Inequality**

\$76,900 was the median income for White families with children compared with \$32,700 for Black and \$41,700 for Hispanic families in 2017.

## **Housing and Homelessness**

- 36,811 homeless children were enrolled in public schools during 2016-2017.
- 1.8 full-time jobs at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

# **Child Hunger and Nutrition**

- 16 percent of children lived in food-insecure households in 2016.
- 33 percent of children ages 10-17 were overweight or obese in 2017.
- 15 percent of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- 87 percent of children receiving free or reducedprice lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

#### Child Health

- 69,177 children ages 0-18 (3 percent) were uninsured in 2017.
- 1,243,479 children ages 0-18 were enrolled in Medicaid and MIChild (Children's Health Insurance Program) in FY2017.

# **Early Childhood**

- \$10,603 was the average annual cost for an infant in center-based child care in 2017.
- **32 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

## **Education**

- 87 percent of Black, 80 percent of Hispanic and 63 percent of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- 86 percent of Black, 75 percent of Hispanic and 61 percent of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- 67 percent of Black, 73 percent of Hispanic and 83 percent of White students graduated high school on time during 2015-2016.
- 19 percent of Black, 7 percent of Hispanic and 4 percent of White public secondary students had at least one out-of-school suspension in 2013-2014.

## **Child Welfare**

- 38,064 children were abused or neglected in 2017.
- **11,918** children were in foster care on the last day of FY2017.

## **Juvenile Justice**

- 1,554 children were in residential placement in 2015. 47 percent were Black; 6 percent were Hispanic; and 40 percent were White.
- **85** children were in adult jails or prisons in 2016.

#### **Gun Violence**

**88** children and teens were killed with guns in
