

# Children in the States 2019

# MISSISSIPPI



## Child Population

- **713,567** children lived in Mississippi in 2017.
- **51 percent** were children of color: 42 percent were Black; 5 percent were Hispanic; 1 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

## Child Poverty

- **27 percent** of Mississippi's children were poor in 2017—a total of **189,541** children—and children of color were disproportionately poor.
- **43 percent** of Black, **24 percent** of Hispanic and **13 percent** of White children were poor.
- **13 percent** of children were extremely poor (their family had income below half the poverty level).
- **26 percent** of children under 6 were poor.

## Income and Wealth Inequality

- **\$71,400** was the median income for White families with children compared with **\$30,900** for Black and **\$41,600** for Hispanic families in 2017.

## Housing and Homelessness

- **9,979** homeless children were enrolled in public schools during 2016-2017.
- **2 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

## Child Hunger and Nutrition

- **24 percent** of children lived in food-insecure households in 2016.
- **41 percent** of children ages 10-17 were overweight or obese in 2017.
- **24 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- **92 percent** of children receiving free or reduced-price lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

## Child Health

- **36,993** children ages 0-18 (**5 percent**) were uninsured in 2017.
- **528,044** children ages 0-18 were enrolled in Mississippi Medicaid and the Children's Health Insurance Program in FY2017.

## Early Childhood

- **\$5,307** was the average annual cost for an infant in center-based child care in 2017.
- **5 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

## Education

- **85 percent** of Black, **76 percent** of Hispanic and **59 percent** of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- **89 percent** of Black, **79 percent** of Hispanic and **61 percent** of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- **79 percent** of Black, **82 percent** of Hispanic and **86 percent** of White students graduated high school on time during 2015-2016.
- **15 percent** of Black, **4 percent** of Hispanic and **5 percent** of White public secondary students had at least one out-of-school suspension in 2013-2014.

## Child Welfare

- **10,429** children were abused or neglected in 2017.
- **5,440** children were in foster care on the last day of FY2017.

## Juvenile Justice

- **243** children were in residential placement in 2015. **77 percent** were Black and **22 percent** were White.
- **24** children were in adult jails or prisons in 2016.

## Gun Violence

- **58** children and teens were killed with guns in 2017.
