Children in the States 2019 **NEW JERSEY**



Child Population

- 1,979,018 children lived in New Jersey in 2017.
- 53 percent were children of color: 13 percent were Black; 27 percent were Hispanic; 10 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- 14 percent of New Jersey's children were poor in 2017–a total of 272,251 children–and children of color were disproportionately poor.
- 26 percent of Black, 23 percent of Hispanic and
 7 percent of White children were poor.
- **6 percent** of children were extremely poor (their family had income below half the poverty level).
- 15 percent of children under 6 were poor.

Income and Wealth Inequality

 \$129,500 was the median income for White families with children compared with \$51,900 for Black and \$49,900 for Hispanic families in 2017.

Housing and Homelessness

- 10,994 homeless children were enrolled in public schools during 2016-2017.
- 3.3 full-time jobs at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

Child Hunger and Nutrition

- **14 percent** of children lived in food-insecure households in 2016.
- **35 percent** of children ages 10-17 were overweight or obese in 2017.
- 40 percent of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- 76 percent of children receiving free or reducedprice lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

Child Health

- 78,200 children ages 0-18 (4 percent) were uninsured in 2017.
- 979,727 children ages 0-18 were enrolled in NJ Medicaid and NJ Family Care (Children's Health Insurance Program) in FY2017.

Early Childhood

- \$12,679 was the average annual cost for an infant in center-based child care in 2017.
- **28 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- 69 percent of Black, 69 percent of Hispanic and 40 percent of White 4th grade public school students could not read at grade level in 2017.
- 76 percent of Black, 72 percent of Hispanic and 41 percent of White 8th grade public school students could not read at grade level in 2017.
- 82 percent of Black, 83 percent of Hispanic and 94 percent of White students graduated high school on time during 2015-2016.
- 13 percent of Black, 5 percent of Hispanic and 2 percent of White public secondary students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- 6,698 children were abused or neglected in 2017.
- 5,946 children were in foster care on the last day of FY2017.

Juvenile Justice

- 636 children were in residential placement in 2015. 72 percent were Black; 18 percent were Hispanic; and 8 percent were White.
- 3 children were in adult jails or prisons in 2016.

Gun Violence

32 children and teens were killed with guns in 2017.
