Children in the States 2019 PENNSYLVANIA



Child Population

- 2,664,515 children lived in Pennsylvania in 2017.
- 33 percent were children of color: 13 percent were Black; 12 percent were Hispanic; 4 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- 17 percent of Pennsylvania's children were poor in 2017–a total of 444,486 children–and children of color were disproportionately poor.
- 33 percent of Black, 36 percent of Hispanic and 11 percent of White children were poor.
- **8 percent** of children were extremely poor (their family had income below half the poverty level).
- 20 percent of children under 6 were poor.

Income and Wealth Inequality

\$87,600 was the median income for White families with children compared with \$38,000 for Black and \$36,300 for Hispanic families in 2017.

Housing and Homelessness

- 25,109 homeless children were enrolled in public schools during 2016-2017.
- 2.7 full-time jobs at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

Child Hunger and Nutrition

- 17 percent of children lived in food-insecure households in 2016.
- 29 percent of children ages 10-17 were overweight or obese in 2017.
- 24 percent of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- 85 percent of children receiving free or reducedprice lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

Child Health

- 124,917 children ages 0-18 (4 percent) were uninsured in 2017.
- 1,589,165 children ages 0-18 were enrolled in Medical Assistance Program (Medicaid) and the Children's Health Insurance Program in FY2017.

Early Childhood

- \$11,560 was the average annual cost for an infant in center-based child care in 2017.
- **14 percent** of 4-year-olds were enrolled in statefunded preschool during 2017-2018.

Education

- 81 percent of Black, 81 percent of Hispanic and
 53 percent of White 4th grade public school students could not read at grade level in 2017.
- 82 percent of Black, 83 percent of Hispanic and 53 percent of White 8th grade public school students could not read at grade level in 2017.
- 73 percent of Black, 73 percent of Hispanic and
 91 percent of White students graduated high school on time during 2015-2016.
- 17 percent of Black, 7 percent of Hispanic and 3 percent of White public secondary students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- 4,625 children were abused or neglected in 2017.
- **16,891** children were in foster care on the last day of FY2017.

Juvenile Justice

- 2,826 children were in residential placement in 2015. 53 percent were Black; 14 percent were Hispanic; and 29 percent were White.
- 29 children were in adult jails or prisons in 2016.

Gun Violence

 135 children and teens were killed with guns in 2017.
