Children in the States 2019 TENNESSEE



Child Population

- 1,507,502 children lived in Tennessee in 2017.
- 35 percent were children of color: 19 percent were Black; 10 percent were Hispanic; 2 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- 21 percent of Tennessee's children were poor in 2017–a total of 314,781 children–and children of color were disproportionately poor.
- 37 percent of Black, 34 percent of Hispanic and
 15 percent of White children were poor.
- 9 percent of children were extremely poor (their family had income below half the poverty level).
- 23 percent of children under 6 were poor.

Income and Wealth Inequality

• \$68,500 was the median income for White families with children compared with \$35,200 for Black and \$35,300 for Hispanic families in 2017.

Housing and Homelessness

- 16,851 homeless children were enrolled in public schools during 2016-2017.
- 2.2 full-time jobs at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

Child Hunger and Nutrition

- 20 percent of children lived in food-insecure households in 2016.
- 38 percent of children ages 10-17 were overweight or obese in 2017.
- 28 percent of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- 86 percent of children receiving free or reducedprice lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

Child Health

- 70,779 children ages 0-18 (4 percent) were uninsured in 2017.
- 1,023,262 children ages 0-18 were enrolled in TennCare (Medicaid) and CoverKids (Children's Health Insurance Program) in FY2017.

Early Childhood

- **\$8,524** was the average annual cost for an infant in center-based child care in 2017.
- **22 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

Education

- 86 percent of Black, 77 percent of Hispanic and 59 percent of White 4th grade public school students could not read at grade level in 2017.
- 87 percent of Black, 80 percent of Hispanic and 62 percent of White 8th grade public school students could not read at grade level in 2017.
- 82 percent of Black, 84 percent of Hispanic and
 91 percent of White students graduated high school on time during 2015-2016.
- 17 percent of Black, 4 percent of Hispanic and 4 percent of White public secondary students had at least one out-of-school suspension in 2013-2014.

Child Welfare

- 8,983 children were abused or neglected in 2017.
- 8,558 children were in foster care on the last day of FY2017.

Juvenile Justice

- 660 children were in residential placement in 2015. 41 percent were Black; 9 percent were Hispanic; and 46 percent were White.
- 8 children were in adult jails or prisons in 2016.

Gun Violence

129 children and teens were killed with guns in 2017.
