# Children in the States 2019 WISCONSIN



## **Child Population**

- **1,282,644** children lived in Wisconsin in 2017.
- 29 percent were children of color: 9 percent were Black; 12 percent were Hispanic; 4 percent were Asian/Native Hawaiian/Other Pacific Islander; and 1 percent were American Indian/Alaska Native.

## **Child Poverty**

- 14 percent of Wisconsin's children were poor in 2017—a total of 181,828 children—and children of color were disproportionately poor.
- 36 percent of Black, 27 percent of Hispanic and
  9 percent of White children were poor.
- **6 percent** of children were extremely poor (their family had income below half the poverty level).
- 16 percent of children under 6 were poor.

## **Income and Wealth Inequality**

\$84,700 was the median income for White families with children compared with \$30,900 for Black and \$40,700 for Hispanic families in 2017.

## **Housing and Homelessness**

- 19,264 homeless children were enrolled in public schools during 2016-2017.
- 2.3 full-time jobs at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in 2018.

## **Child Hunger and Nutrition**

- **16 percent** of children lived in food-insecure households in 2016.
- **26 percent** of children ages 10-17 were overweight or obese in 2017.
- 11 percent of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2017.
- 85 percent of children receiving free or reducedprice lunch during the 2016-2017 school year did not participate in Summer Nutrition Programs in 2017.

#### Child Health

- 52,730 children ages 0-18 (4 percent) were uninsured in 2017.
- 709,711 children ages 0-18 were enrolled in Medicaid and BadgerCare Plus (Children's Health Insurance Program) in FY2017.

# **Early Childhood**

- \$12,268 was the average annual cost for an infant in center-based child care in 2017.
- **68 percent** of 4-year-olds were enrolled in state-funded preschool during 2017-2018.

## **Education**

- 86 percent of Black, 84 percent of Hispanic and 59 percent of White 4<sup>th</sup> grade public school students could not read at grade level in 2017.
- 91 percent of Black, 77 percent of Hispanic and 55 percent of White 8<sup>th</sup> grade public school students could not read at grade level in 2017.
- 64 percent of Black, 80 percent of Hispanic and
  93 percent of White students graduated high school on time during 2015-2016.
- 17 percent of Black, 4 percent of Hispanic and 2 percent of White public secondary students had at least one out-of-school suspension in 2013-2014.

## **Child Welfare**

- 4,902 children were abused or neglected in 2017.
- 7,721 children were in foster care on the last day of FY2017.

## **Juvenile Justice**

- 762 children were in residential placement in 2015. 56 percent were Black; 9 percent were Hispanic; and 28 percent were White.
- 37 children were in adult jails or prisons in 2016.

## **Gun Violence**

**47** children and teens were killed with guns in 2017.
