

The State of America's Children® in KENTUCKY

2021 Factsheet



Child Population

- **1,002,871** children lived in Kentucky in 2019.
- **22 percent** were children of color: 9 percent were Black; 7 percent were Hispanic; 2 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **22 percent** of Kentucky's children were poor in 2019—a total of **212,130** children—and children of color were disproportionately poor.
- **32 percent** of Black, **30 percent** of Hispanic and **19 percent** of white children were poor.
- **11 percent** of children were extremely poor (their family had income below half the poverty level).
- **26 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$69,300** was the median income for white families with children compared with **\$39,600** for Black and **\$45,600** for Hispanic families in 2019.

Housing and Homelessness

- **23,964** unhoused children were enrolled in public schools during 2017-2018.
- **2.1 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in FY2020.

Child Hunger and Nutrition

- **19 percent** of children lived in food-insecure households in 2018.
- **24 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2018.
- **91 percent** of children receiving free or reduced-price lunch during the 2018-2019 school year did not participate in Summer Nutrition Programs in 2019.

Child Health

- **45,091** children ages 0-18 (**4 percent**) were uninsured in 2019.
- **551,738** children ages 0-18 were enrolled in Kentucky Medicaid and KCHIP (Children's Health Insurance Program) in 2019.

Early Childhood

- **\$7,574** was the average annual cost for an infant in center-based child care in 2019.
- **29 percent** of 4-year-olds were enrolled in state-funded preschool during 2018-2019.

Education

- **86 percent** of Black, **76 percent** of Hispanic and **61 percent** of white 4th grade public school students were not proficient in reading in 2019.
- **86 percent** of Black, **73 percent** of Hispanic and **64 percent** of white 8th grade public school students were not proficient in reading in 2019.
- **82 percent** of Black, **83 percent** of Hispanic and **92 percent** of white students graduated high school on time during 2017-2018.
- **13 percent** of Black, **3 percent** of Hispanic and **4 percent** of white public secondary students had at least one out-of-school suspension in 2015-2016.

Child Welfare

- **20,130** children were abused or neglected in 2019.
- **9,148** children were in foster care on the last day of FY2019.

Youth Justice

- **555** children were in residential placement in 2017. **33 percent** were Black; **4 percent** were Hispanic; and **55 percent** were white.
- **0** children were in adult jails or prisons in 2019.

Gun Violence

- **58** children and teens were killed with guns in 2019.
