

The State of America's Children® in MINNESOTA

2021 Factsheet



Child Population

- **1,303,157** children lived in Minnesota in 2019.
- **32 percent** were children of color: 10 percent were Black; 9 percent were Hispanic; 6 percent were Asian/Native Hawaiian/Other Pacific Islander; and 1 percent were American Indian/Alaska Native.

Child Poverty

- **11 percent** of Minnesota's children were poor in 2019—a total of **143,006** children—and children of color were disproportionately poor.
- **37 percent** of Black, **17 percent** of Hispanic and **6 percent** of white children were poor.
- **5 percent** of children were extremely poor (their family had income below half the poverty level).
- **11 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$108,600** was the median income for white families with children compared with **\$41,600** for Black and **\$52,900** for Hispanic families in 2019.

Housing and Homelessness

- **16,698** unhoused children were enrolled in public schools during 2017-2018.
- **2.1 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in FY2020.

Child Hunger and Nutrition

- **12 percent** of children lived in food-insecure households in 2018.
- **14 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2018.
- **83 percent** of children receiving free or reduced-price lunch during the 2018-2019 school year did not participate in Summer Nutrition Programs in 2019.

Child Health

- **42,387** children ages 0-18 (**3 percent**) were uninsured in 2019.
- **530,404** children ages 0-18 were enrolled in Medical Assistance (Medicaid) and MinnesotaCare (Children's Health Insurance Program) in 2019.

Early Childhood

- **\$16,164** was the average annual cost for an infant in center-based child care in 2019.
- **10 percent** of 4-year-olds were enrolled in state-funded preschool during 2018-2019.

Education

- **81 percent** of Black, **81 percent** of Hispanic and **54 percent** of white 4th grade public school students were not proficient in reading in 2019.
- **89 percent** of Black, **82 percent** of Hispanic and **59 percent** of white 8th grade public school students were not proficient in reading in 2019.
- **67 percent** of Black, **67 percent** of Hispanic and **88 percent** of white students graduated high school on time during 2017-2018.
- **13 percent** of Black, **4 percent** of Hispanic and **2 percent** of white public secondary students had at least one out-of-school suspension in 2015-2016.

Child Welfare

- **6,780** children were abused or neglected in 2019.
- **8,400** children were in foster care on the last day of FY2019.

Youth Justice

- **675** children were in residential placement in 2017. **42 percent** were Black; **7 percent** were Hispanic; and **35 percent** were white.
- **4** children were in adult jails or prisons in 2019.

Gun Violence

- **37** children and teens were killed with guns in 2019.
